The meeting was called to order by President Justin Lindsley at 7:00pm.

A motion to approve the September minutes was made by Craig Freeman and seconded by Aubrey Ptacek. Peter abstained from the vote due to his absence from the last meeting.

#### **Executive Director Report:**

- Dashboard was reviewed, including unemployment numbers.
- SmartSheets where we are logging transition information.

Executive Director job description draft was presented. Some discussion on possible changes took place.

- A subcommittee was formed to hire a new executive director.
- Discussion on transition, some ideas presented, nothing set.
- Banking signors decided to leave as is will not make changes until new executive director is hired.
- Colby Richard motioned to accept Stacie's resignation. Jon Halbgewachs seconded. Motion passed unanimously.
- Notifications to business contacts, represented members/classes, and partners will be done by board members and our office. Board members will make personal calls on 10/31/24, then on 11/1/24, public announcements will start going out.

Jim Kirkbride made a motion to appoint Michelle Skurkis as interim director, effective 11/15/24 until permanent position is filled. Olivia Stevenson seconded the motion. Motion passed unanimously.

Motion was made to enter into executive session at 7:32, for 15 minutes, to discuss compensation for Michelle Skurkis.

Following the Executive Session, a motion was made to approve Michelle Skurkis additional compensation of 20% effective November 18 until a Director is hired by Craig Freeman and seconded by Aubrey Ptacek. Motion passed unanimously.

A motion was made to hire Stacie as a consultant for up to 10 hours/week at her current hourly wage by Sara Oberle and seconded by Colby Richard. Motion passed unanimously.

A motion was made to authorize the annual salary for the Executive Director as a range of \$60,000-\$80,000 with authority given to the search committee for a relocation package of up to \$10,000 by Curt Glaser and seconded by Craig Freeman. Motion passed unanimously.

A motion was made to authorize a search committee consisting of the Executive Board, Sara Oberle, and Colby Richard to meet independently and make decisions on recruitment by Olivia Stevenson and seconded by Aubrey Ptacek. Motion passed unanimously

A motion to adjourn at 8:16 was made by Curt Glaser and seconded by Craig Freeman.
